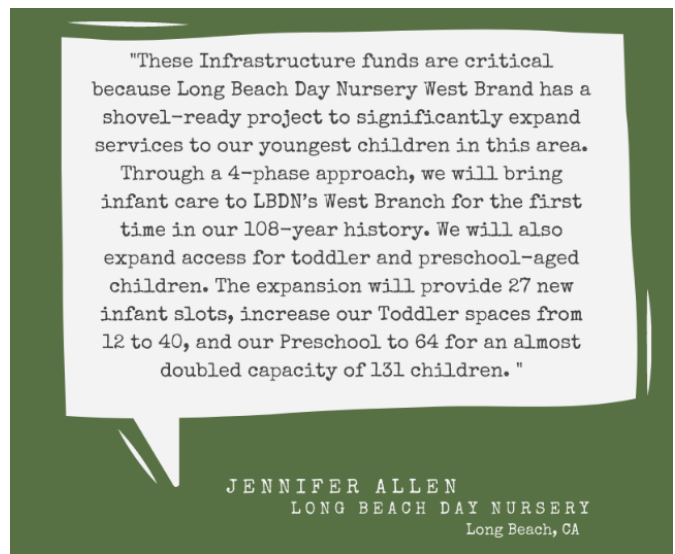

**Re: Build Back Better - The Need for Investment in Child Care Physical Facilities**

As negotiations on the Build Back Better Act advance, **we urge Congress to invest at least \$15 billion for child care infrastructure grants as part of the Build Back Better bill, following the example provided by the House Ways and Means Committee.** These grants can be used to acquire, construct, and renovate facilities and are accompanied by critical technical assistance and capacity-building support from experienced intermediaries.

**While funding the other aspects of the child care system, like the workforce, continue to be crucial, funding for facilities' physical infrastructure is especially critical.** The messages below illustrate the great need for investment in child care facilities in our communities:



President Biden acknowledged the importance of physical spaces by proposing \$25 billion to improve early learning facilities in the American Jobs Plan. Investments seeking to increase child care affordability, accessibility, and workforce compensation will have limited success without an adequate supply of physical facilities to operate child care programs and ensure children's and educators' health and safety.

Failure to establish a standalone investment in a child care facility infrastructure grants program in this once-in-a-generation reconciliation package will only perpetuate structural inequities. This funding will support low-income and BIPOC communities to mitigate pandemic conditions, address learning loss, support the workforce, and create jobs by providing safe and resilient center-based and home-based programs where children and families thrive.

In California, demand far exceeds the supply for high-quality child care, particularly for low-income families. Based on information from the American Institutes for Research, there is an estimated gap of over 482,248 child care slots just for children from low-income families. Our early care and education facilities infrastructure serve less than a quarter of our state's youngest learners. Before the pandemic, [60% of all California's children lived in a child care desert](#). The COVID-19 pandemic has only exacerbated the state's ECE capacity problem. These numbers equate to real Californians who must find alternative care arrangements or forgo employment opportunities to stay home to care for their children.

As negotiations advance, we urge you to speak directly with Senator Murray (D-WA) and emphasize the importance of dedicated, standalone child care facility infrastructure grants as a critical element of the budget reconciliation bill. These resources are essential to realizing the full benefits of the Build Back Better Plan's investments in the child care ecosystem.

We appreciate your attention to this critical issue and support for the child care sector.
